# Pastor's Message

Change can be difficult, and blessed

Jesus says, "Whoever wants to be my disciple must deny themselves and take up their cross and follow me."

Matthew 16:24

# Congregational Council Meeting, August 12, 2024

- † A six o'clock pm regular meeting of the Congregational Council of St. Paul's ELCA was called into session by Council President Zola Finch. Council members present were Kent Nelson, A.J Ferrell, Stacy Bubach, Jana Thompson, and Frank Pascoe. Absent were members Misty Schroeder, Devin Koestner, and Ashleigh Hillen. Also present were Pastor David Viles, Church Treasurer Kay Pascoe, and incoming Church Treasurer Michelle Collins.
- **†** The meeting opened with a prayer by Pastor Viles. The president requested a motion to approve the minutes of the previous Council minutes of July 8th which was sent out via email. This was accomplished upon a motion by A.J. Ferrell, seconded by Kent Nelson and approved by all.
- † The president called upon Church Treasurer Kay Pascoe to present a summary of church finances. The treasurer presented a four-page account of the Church's expenses and income. She reported that Farmers Bank of Lohman's CD #3143 can be renewed at @ 4.75% until April of 2025. All Council members verbally agreed that it be renewed. The Treasurer's statement of financial position reported a year-to-date balance of cash & investments of \$300,763.98. The total for dedicated accounts was \$34,392.55. Income for July 2024 totaled \$12,249.43. Expense totals for July 2024 showed \$14,035.02. There was brief discussion on various ways to record and make note of "interest income". The Treasurer has written the Cole R-1 Schools to remind the school that the church has issued a stop-payment for the two uncashed checks totaling \$1,000. Several Council members offered to remind Russellville School office personnel of this ongoing issue. Michelle Collins was at this time noted as the incoming Church Treasurer. There was brief discussion of her possible choices of accounting methods and various choices of computer-based software.. The Council members offered thanks to Kay Pascoe for her more than twenty years serving as St. Paul's Church Treasurer.
- † The President called upon Pastor Viles to present an account of his July activities. Pastor Viles' statement showed a total of 151 miles of July travel. He requested no mileage compensation of \$101.17. He attended the Vacation Bible School sessions at Trinity Church in Russellville. He drove a parishioner to Columbia for a medical procedure. His various meetings included Worship & Music, Lions Club, Lohman City Council, S.T.A.R.S., Area Ministerial Alliance, and Worship & Music Committee. Pastor had home visits with parishioners and Nursing Home visits. He held personal counseling visits with parishioners. He met with Debbie Boyce to discuss plans for the Church's 100th anniversary. He held the Baptism of Clara Barker on July 27th. He attended the 50th wedding anniversary of Jana & Harry Thompson. He updated the Church's Website, created the August "Epistle", and prepared the Sunday bulletins, and e-mailed them. He presided over four July worship services, two-communion and two non-communion services. Each was done in-person and online.

President Finch called upon Council Committee Chairpersons to report on their recent activities:

**Evangelism:** Chair Misty Schroeder was not well and was not in attendance. Misty briefly discussed in a short phone call to the Council tentative plans for a Social Sunday in the fall, perhaps involving Trinity Lutheran in Russellville and St. Paul's.

**Technology:** Chair Devin Koestner was absent. President Zola Finch reported that she will speak soon to Will West Music & Sound regarding the installation of the Screens. She noted that a priority for our church is the recruitment of volunteers to learn to manage the operation of the screens once installed. A plea for those willing to assist could be published in the Epistle and Sunday Bulletins might be a first step. There was brief discussion that the planned zoom during the children's sermon was working as planned.

Worship & Music: Chair Ashleigh Hillen submitted an e-mailed summary of that Committee's recent meeting. Seven members were in attendance. Baptism services were discussed. If held in private and not during Sunday services, it was expressed that the sponsors names be listed in the Sunday Bulletin. The upcoming 100th Anniversary service was discussed and the need for planning. The collections of Sunday offerings with ushers passing the plates during the service was discussed. Most opinions expressed felt that it should be kept as part of the service. The group decided that Setting 4 will start in September. The Bell Choir will play on Labor Day service. The Chili Supper is planned for October 6th with Reformation Sunday and 100th anniversary Sunday on Oct. 27th. The committee selected the hymns for September services.

Parish Education: A.J. Ferrell. Sunday School began in August and will be held twice a month. Children will have an opportunity to put their handprints on the Sunday School wall tree image next Sunday, the 18th. A.J. reported that there is much interest among parents to have a refurbished or replaced playground at St. Paul's. This might involve a total disassembly of the old one, or a relocation of the new one to a different spot on church grounds. The committee could investigate to see if a grant might be available to accomplish this. Planning must soon start to see if a Christmas program [traditional or something new?] is to be held at St. Paul's. Much discussion followed on the choice of a date, whether on Christmas Eve or some other time. The Parish Education committee will discuss and bring back ideas to the Council.

**Church Improvement:** Kent Nelson will soon announce a fall work-day date in September. Work on tree trimming and cutting down will soon resume.

**Stewardship & Finance:** Stacy Bubach reported that Michelle Collins acceptance of the Church Treasurer position is for us to finalize this evening. It was agreed that she will become Church Treasurer on Sunday August 18th, with an hourly pay set at \$20.00. This was agreed to by all upon a motion offered by Kent Nelson, seconded by A.J. Ferrell and approved by all.

Mutual Ministry: Chair Jana Thompson reported no meeting in the past month.

**Old Business:** The Safety Committee is currently at rest. A meeting of those members interested will meet later this month. Kent Nelson will meet with those members who are still interested in participation. The need for congregational evacuation drill practice during storms is needed as these have been put off for some time. The Safety Committee could also address a procedure in the case of a medical emergency.

**New Business:** It was announced by Pastor Viles that a parishioner is interested in renting the parsonage. President Finch offered to come up with a written contract for the parishioner to agree to and formally sign. This will take place very shortly and will be shared with all Council members. A vote to move forward with the rental agreement was agreed to by all upon a motion offered by Frank Pascoe and seconded by Jana Thompson.

President Finch declared the meeting at an end upon a motion by A.J. Ferrell, seconded by Kent Nelson and agreed to by all. The meeting closed with The Lord's Prayer.

# Congregational Council Meeting, September 9, 2024

† A regular six o'clock pm meeting of the Congregational Council of St. Paul's Church was called to order by Council President Zola Finch. Council members present were Kent Nelson, A.J. Ferrell, Jana Thompson, Misty Schroeder, Ashleigh Hillen, and Frank Pascoe. Also present were Church Treasurer Michelle Collins and Pastor Daid Viles.

- † The meeting opened with a prayer by President Finch. President Finch requested a motion to approve the minutes of the previous Council minutes of August 12th. This was accomplished by a motion to approve by Kent Nelson, seconded by A.J. Ferrell, and agreed to by all.
- † The President requested Church Treasurer Michelle Collins to present a monthly report. The Treasurer distributed a four-page detailed accounting of the Church's income and expenses dated August 31, 2024. The report showed total liabilities and net assets of \$302,137.64; dedicated accounts ending balance of \$35,578.93; and current monthly income of a positive \$2,118.28 over monthly expenses. This month, being the first monthly report to the Council by new Church Treasurer Michelle Collins, she had several questions to the Council regarding financial procedures, establishing accounts, and the writing of Church checks. Her questions were answered by various Council members. President Finch informed the Council regarding the current disturbing increase in check fraud and urged increased use of online banking with Farmers Bank of Lohman.
- † The President requested that Pastor Viles present his monthly report. His report contained no request for mileage for August. His report detailed five meetings with parishioners and community groups, including Lions Club, Church Council, S.T.A.R.S. and Mutual Ministry. He had home visits as well as counseling sessions with three members. Pastor spent many hours at home with his wife Donna during her time with Hospice care. He opened Friendship Hall several times to accommodate voting on August election day. He performed the baptism of Cory Soell, son of Scott and Vanessa. Pastor updated the Church website, prepared worship bulletins and the August Epistle. He presided at two Communion Sunday services and two non-Communion Sunday services.

President Finch discussed Sunday morning arrangements for the upcoming Sunday of Sept. 15th, when the sermon will be delivered by supply speaker Mr. David Stock of Holts Summit. She requested that Jana Thompson open the service with announcements and to also do the Children's sermon. President Finch will provide details for that Sunday to the supply pastor. There will be no Communion service on Sept. 15th.

President Finch called upon Council Committee Chairpersons to report on their recent activities:

**Evangelism:** Misty Schroeder detailed the planning that is currently ongoing for the Chili Supper to be held on Oct. 6th. The work detail sheets have already been distributed to the various workers. For the 100th Year Anniversary celebration which will be held on Sunday October 27th, Debbie Boyce is planning a wide range of celebratory activities. These will be announced in the coming weeks.

**Technology:** In Devin Koestner's absence, President Finch briefly brought the Council up to date on the upcoming installation of the sanctuary screens, as well as the continuing need for additional help for running the slides after screens are installed. President Finch also discussed issues related to diverting our streaming process during the children's sermon. President Finch has been investigating the policies and recommendations of our ELCA authorities regarding on-line streaming of the Sunday services and other events. She distributed a document from the ELCA with basic suggestions for recording and livestreaming and how to inform congregations. This will be a topic for future Council meetings.

Worship & Music: Ashleigh Hillen discussed this committee's most recent meeting which was on Sept. 3rd. She relayed to the Council a request from the Worship & Music members to add a children's hymn on those Sundays which have Sunday School following the Children's sermon. The lyrics might be added to the Sunday Bulletin on those Sundays. She noted that the Committee has chosen hymns for October.

**Parish Education:** A.J. Ferrell reported on this group's recent ideas for a Christmas Eve program. There was brief discussion on which night would be most ideal for the program. The preference was for Christmas Eve itself. A survey of children and their parents will be held to see how many might participate. A.J. reported no new movement on the idea of a new or refurbished playground.

Church Improvement: Kent Nelson updated the Council on continuing ideas for tree trimming. He has secured the assistance of Jason Plochberger on that project. October 5th has been chosen for fall workday. Marvin Bubach will brush-hog the areas needing attention. The contracted firm for our Cemetery will be asked to return for a clean-up of the cemetery. Korsmeyer Fire Protection service has been asked to come and re-charge our fire extinguishers. Kent has been working on the lighting problems in the church office on second floor.

**Stewardship & Finance:** Stacy Bubach reported on the successful transition of Michelle Collins into the position of Church Treasurer. She thanked Kay Pascoe for her years of service in that position.

Mutual Ministry: Jana Thompson reported on an August 21st meeting of her committee. Six members were present. Possible social Sundays with Trinity Church Russellville were discussed. Debbie Boyce shared her plans for the Reformation Sunday 100th Anniversary of our building. A guided tour of the church grounds was suggested as this would indicate just where past buildings were located. Our Sunday School teachers and their efforts were praised. The Committee will try to encourage some of our teenage members to assist with the technology of screen display once the new screens are in place. Most members who commented during the meeting were in favor of continuing to pass the offering plates during the service. The use of the parsonage as a rental was discussed. Some thought that there might be a conflict of interest since St. Paul's is a non-profit entity. This will be investigated. Mutual Ministry's next meeting will be on Sept. 18th.

**Old Business:** President Finch spoke regarding the Parsonage rental. She indicated as long as St. Paul's designates our rental as "transitional housing" for our own members, or others in need, this arrangement is simply just part of "God's Plan", and is not a lease in the commercial sense. Any fee paid by a renter is simply a contribution toward the yearly property tax.

#### **New Business:** None

It was announced that the Train Ride to Herman, Missouri will take place on Sept. 22nd.

The meeting was declared adjourned upon a motion by Jana Thompson, seconded by A.J. Ferrell, and approved via voice vote. With the recitation of the Lord's Prayer, the meeting closed. Respectfully submitted by Frank Pascoe, Council Secretary.
